# Portland Neighbourhood Plan Habitats Regulations Assessment: Addendum

July 2019

This document provides an update to the Habitats Regulations Assessment (HRA) following the statutory consultation with Natural England, the 'appropriate nature conservation body' in this instance.

Natural England were consulted on the HRA of the Portland Neighbourhood Plan on 3<sup>rd</sup> June 2019 in accordance with Regulation 63(3) of the Conservation of Habitats and Species Regulations 2017 (as amended). Natural England's comments are presented in Appendix A of this report.

Natural England were generally satisfied with the recommentions of the HRA but suggested an amendment to the recommendation for the overarching wildlife policy in the Portland Neighbourhood Plan, which would largely reflect ENV2 of the adopted West Dorset, Weymouth & Portland Local Plan (2015). The suggested amendment ensures that the integrity of European Sites is not compromised by the Northern Arc proposal in the Portland Neighbourhood Plan.

The recommendations in full, following Natural England's comments, are now:

 Add a new policy to reflect policy ENV2 of the adopted West Dorset, Weymouth & Portland, which includes the following wording:

> "Proposals that will adversely affect the integrity of European sites will not be supported. Any development bought forward regarding the Northern Arc or enhancement of the piers must ensure that it can be implemented without any adverse effect upon the integrity of the European sites"

- Policies EN5 (Historic Piers), EN8 (The Verne) and BE6 (Northern Arc) amended to
  ensure that no adverse effects on the integrity of European sites occurs as a result of
  water pollution stemming from site runoff or dust emissions during construction or the
  operational stage of each of the development
- Policy ST1 (Sustainable Tourism Development) expanded slightly to include the specific qualification that support will not be given to any tourism development that will adversely affect European sites.

As explained in the HRA, it is necessary for these recommended changes to be made to the Portland Neighbourhood Plan in order to achieve compliance with the European Union's Council Directive 92/43/EEC, on the conservation of natural habitats and of wild fauna and flora (also known as the 'Habitats Directive'), which is transposed into U.K law through the Conservation of Habitats and Species Regulations 2017 (as amended).

Many thanks for the opportunity to review the HRA and AA for the Portland Neighbourhood Plan.

I am generally satisfied with the conclusions of the HRA and support the recommended changes, however, I would like to clarify how the risk of direct land take issues relating to Policy BE6 (The Northern Arc) are being addressed.

The recommended new safeguarding NP policy specifically refers to use of the piers ie:

"Any development bought forward regarding **enhancement of the piers** for social or economic use must ensure that it can be implemented without any adverse effect upon the integrity of the European sites. Proposals that will adversely affect the integrity of European sites will not be supported."

As written this therefore could be interpreted as excluding Policy BE6 (Northern Arc) – which deals with development other than that involving the piers. I would suggest therefore that this new NP safeguarding policy is expanded to specifically include any development proposals that would be supported by policy BE6.
