Regulation 16 publication of Bere Regis Neighbourhood Plan

Bere Regis Parish Council have submitted the final draft of their Neighbourhood Plan to Purbeck District Council.

The plan sets out the community's long term vision and policies for the village. It can be viewed together with supporting documents and the form on which you should make comments online at www.dorsetforyou.gov.uk/purbeck-neighbourhood-plans-in-progress. Hard copies of the Local Plan and supporting documents are available to view at District Council's offices in Worgret Road, Wareham, response forms can also be obtained from the Bere Regis Parish Clerk. All comments must be made using the form provided and received during the six week period.

The regulation 16 consultation is carried out by the District Council and is an opportunity to ask the public and specific consultees for their opinions on the Bere Regis Neighbourhood Plan. This is an important stage as it is the last chance for you to make comments on the Plan. Following this

consultation, the plan will be submitted to a planning inspector for examination. If agreed by the Council and the planning inspector, a referendum will be held followed by the plan being formally adopted and used to determine planning applications in the Neighbourhood planning area.

The statutory six week period for making comments starts on **Monday 15 October and all responses should be received by Monday 26 November 2018.**
