Stalbridge has been my nearest town for the past 35 years. I am dismayed to see how the High Forest has deteriorated during that time: increasing heavy traffic making it unpleasant and in places dangerous to walk about; shop closures, including the newsagent, the bank, the butchers, the greengrocer, the fishing tackle shop. I accept that some limited expansion of the town is necessary to provide homes for local people, but not at the expense of building large developments on green fields, particularly to the East & North of the town, and certainly not by allowing greedy developers to ride roughshod over the local planning authority.
