Employment

Really feel that any large scale builders programme should be matched by an increase in the number of jobs on offer.

Too many jobs locally seem to be part time, minimum wage. Very difficult for local people to be able to afford the proposed new homes.

I would think that business parks, areas for small factories etc should go hand in hand with the new housing



The problem as I see it with building large numbers of new houses in North Dorset is that it sucks in people from the home counties looking to retire/relocate with the proceeds of selling expensive houses.

This buying power drives up house prices here making it very difficult for local people who are often on low incomes.
