Education Meeting at Emmanuel Middle School, Verwood

16 November 2010

Issues discussed

This meeting was a follow up to the Verwood Focus Group on 12th November and allowed a more detailed appraisal of the schools in Verwood.

1. School numbers and allowed we are lifted of claim years yell to it passes are

Predicted numbers for the age group 5+ Reception - (information from Anne George, Dorset CC Education provided by Adam Parsons)

Numbers are relatively constant throughout the next few years. There is always some leakage to other local village schools – Cranborne First, St James, Gaunt's Common and St James, Alderholt.

2. Spare Capacity augmed looded and no political than see

Across the 3 first schools, there are 20 places spare in each year group. Only Trinity has space on site on which to expand to provide 2 form entry. Land has been set aside for this. It was felt by all that it would be better to fill up the existing schools, than build a further new first school. – Roger said this was a possibility.

Hillside First has most space, with a PAN number of 60, and 210 pupils currently in school.

Emmanuel

At Emmanuel, the school has 483 children on the roll in 17 classes. There is one year with 5 forms, and three with 4 forms. Jill explained she can currently accommodate up to 510 (a further 27 children) within the school at a stretch. However, the LEA number for the school is potentially 600 (5 classes of 30 = 150 over 4 years), which she physically cannot accommodate within current classrooms.

We understand it is unlikely that the county council will reduce the school's PAN number and it will remain at 600, even though this number of pupils cannot be accommodated within the present site.

3. Traffic and parking at Verwood First School and Emmanuel

There is already a major problem of parking and access into the campus, and suggestions were made about changing the entrance of Emmanuel to the south of the site from Howe Lane or St Michael's Road. This may be possible should housing come forward on land nearby, but there is clearly a problem which needs addressing in the short term.

4. The Diocese

The Diocese has interests in Emmanuel, Trinity and Verwood First Schools and will need to be involved in the future plans associated with them. Roger suggested that they may wish to build a new school in the town to accommodate new pupils. We have met Chris Shepherd of the Diocese who is very interested in the schools in Verwood and future growth in the town. They maintain strong links with Dorset County Council about decisions for the future and have an interest in additional school development in Verwood.

5. Affordable Housing

Adam asked about the ratio of affordable housing (40 - 50%) and the impact this could have on the local community, pressures within school and possible changing of the school's ethos. Some children will need additional help and support from within school. Currently there are very few children who receive free school meals.

6. Youth Centre

This is a large purpose built building on the school campus, owned and run by the county council. It has a large hall and other facilities, used by Surestart and the extended schools agenda – breakfast and after schools clubs. Neither Emmanuel nor Verwood First School have regular access to the premises, and it was considered this is a vital asset not fully realised. It's distance across the car park from the main school buildings does not relate well to the rest of Emmanuel, but it has the potential to be a valuable resource in the future.

Questions asked

(i) What is the trigger number for a new upper school in Verwood?

1000 upper school pupils would trigger the need for an upper school in Verwood. Ideally, if it could be an 8 form entry it would be a better school offering a good curriculum range and able to compete against other local schools such as QE.

(ii) What is the ratio of new pupils to new housing – how many per year group could there be?

Approximately 1000 homes would trigger the need for a new first school with 30 per year group.

(iii) When would the housing be built?

The earliest that housing could start would be in 2 years time, once the Core Strategy is formally adopted. However, Option VWM3 could happen earlier as it is within the urban area of Verwood, not the green belt (see comments below).

(iv) How many houses would be built each year?

This depends on the size of the site and the individual developer. It could be up to around 50 per year for each site, but this will depend on the market conditions, and if they are slow to sell, work will stop. So a site of 180/200 homes will take about 4 years to be built.

(v) Who owns the land close to Verwood First School?

Option VWM4 south of Manor Road is owned by 2 owners. The land to the east of St Michael's Road (including Potterne Dairy) is owned by a developer. The smaller parcel to the west of St Michael's Road is owned by the owner of Cranebrook Manor. We understand the owners do not wish to develop it at the current time.

The land immediately to the east of the school (Option VWM3) is owned by Mr Spencer. This land is not in the green belt and could be developed at any point in time. However, the access is difficult into the site, and there is a listed house and protected trees on the site, which is why it hasn't already taken place. Mr Spencer lives in Spain but maintains contact with the District Council.

John Shave explained that there was also another meeting taking place with Richard Henshaw that several of the absentees were attending.

Overview of the Core Strategy Consultation - Judy Windwood

Judy outlined the main points of the consultation explaining that the items to be considered by the TAG were:-

- Main transport proposals
- Key proposal options
- Group items for response should be district wide concerns
- Individual responses should address specific regional issues, e.g. West Moors Bypass

Housing Options

These include:-

- New neighbourhood sites on the peripheral areas of existing developed regions
- Urban extensions
- Airport expansion/development including business park expansion
- Open space and community facilities to be incorporated

Copies of the Key Strategy from the Core Strategy Options were distributed

- The committee were asked to consider the implications of the housing proposals with regard to transport.
- No overall target is now set for the number of properties to be built between now and 2027.
- Several sites have been identified as options for development and the sites to be considered will be put out for consultation in the autumn of 2011.
- 30 hectares of suitable land has been put forward by EDDC for commercial expansion/employment.

The Christchurch and East Dorset Core Strategy consultation is now in its seventh week and was due to end prior to Christmas. This deadline has been extended until three weeks after Christmas (14th January) due to master plan updates that are currently being put on the Internet. This date may be extended further if necessary.

Transport Options - Kate Tunks

Sustainable locations for expansion are to include vehicle transportation, cycling, and road infrastructure. The Key Transport Corridors are to be developed in line with The Key Strategy. Maps had been distributed for information identifying The Key Transport Corridors.

Items to be considered for improvement:-

- Public transport services real time information at bus stops
- Travel plans required for new residential, commercial and industrial developments
- Rural areas pilot community travel planning give the community more say
- Speed reduction measures funding may restrict this to the south of the A31

Alternative options for improvements:-

- Developers to provide access to new sites as opposed to councils and the wider authorities
- Parking levels to be improved aim to encourage people out of their cars Park and Ride
- Walking, cycling and public transport improvement to facilities

Kate explained that the TAG needed to identify their preferred options for inclusion when responding to the consultation.

- Consider the right approach
- What form transport should take
- Be creative within available funding

Identify timing of action plans, e.g.

Short term

Canford Bottom roundabout 2011

Medium term

A35 improvements to roundabouts and junctions

Long term

A31 – loss of regional funding has left a question mark over the future

West Parley junctions with the B3073

Question Time

- Q. Would the infrastructure levy affect house prices by being passed on by the developer?
- A. The levy is on land prices, not house prices, therefore the developer is aware from the outset the costs he will incur. The construction costs will take this into account.

 West Moors Oakhurst School Signage funding £392.
- Q. Will Canford Bottom roundabout definitely go ahead considering the present cut backs?
- A. There is great confidence in the funding of the project due to the Olympics in 2012. Site preliminaries are planned to start in February 2011 with full works starting in April.
- Q. What are the future plans for the A338?
- A. The next round of funding will be allocated in January 2011, no plans will be made until then.
- Q. What is the likelihood of a bypass for West Moors within the Core Strategy until 2027?
- A. This does not form part of the plan, however the corridor is being examined to see if public transport, cycling and walking can be improved along with some small scale road improvements.
- **Q.** Is there enough finance for adequate improvements in public transport?
- A. Funding will be available for DCC to purchase buses and improve fares.

- Q. Are there any plans to address the problems in Horton Road which takes heavy vehicles out of scale with the road?
- KT said that management work could be undertaken but it was very unlikely that anything could be done due to lack of funding. It was suggested that expansion of Woolsbridge industrial estate could increase traffic in the area, but improvements could reduce commuter traffic which would reduce traffic in general.
- Q. Is there too much reliance on walking and cycling to the workplace?
- KT said it was important to get alternatives to the car in place as soon as possible before fuel A. prices rise further.

General Discussion on Specifics

West Moors Wilts & Dorset have removed some of their buses.

Wandering residents causes danger on the roads – affecting drivers and pedestrians.

Can revenue from mitigation schemes with contractors be watertight to prevent avoidance of payment?

Wilts & Dorset

W & D receive constant criticism for late services. This cannot be improved until the junctions and roundabouts are adequately improved to enable efficient traffic flow. Bad weather also impacts on timetables due to increase of traffic, slowing flow down even further. A31 Ferndown to Poole is particularly difficult frequently running late.

Alderholt

Alderholt does not appear to feature at all in any of the transport studies but has issues that require attention, e.g. HGVs using inadequate roads.

Vale of Allen

Over 500 houses are designated to be constructed north of Wimborne, including 250 affordable houses. There is no industry in the area and therefore no employment. JW explained that Wimborne has been identified as a major settlement with a considerable town centre. Public transport options will be implemented to enable commuters to travel to work. The sites for development have been identified where there is the opportunity for walking to work. In a many many more and bloods much and below

Ferndown T C

The priority should be the infrastructure, not what and where to build.

Dorset Cycle Net

Paramount to lower speed limits to make cycling safer. The previous government were intending to give local government the option to lower the bloods along upper speed limits. Speed limits should be inherent to the local plan. Cycle ways must be made safer with all weather surface. They are a cheap option and developers could provide them as happened at Bournemouth Airport, within a very short time span.

St Leonards & Ives Horton Road is unsafe and requires major improvement to accommodate existing industry and future development, both housing and industrial/commercial. Cycle routes to the existing industrial estates within East Dorset require improvement and expansion. KT explained that funding for this has already been acquired for this and improvements and extension to existing routes will be carried out shortly.

John Cumming- Bus Subsidy and Funding

- Rural bus grants will no longer be ring fenced and there will be no guarantee the funding will be used for transport.
- Budgets for surrounding areas have already been reduced and agreed. Dorset's budget is still being formulated.
 - DCC subsidise passenger transport to a large extent. DCC are responsible for the funding of concessionary travel. (The scheme began four years ago and each year the subsidy, per passenger, from central government has reduced. It is now down to 34p from the original 67p approximately.
 - Tendering is going out at present and will be finalised in January 2011. Changes will be introduced in April 2011.
 - Fuel duty rebates to bus companies are due to be dramatically reduced over the next few years.
 - The age for children's fares has been raised to nineteen, to encourage children to use buses.
 - Funding will be provided from central government for Smart Card Readers on buses. Pensioner bus passes will be scanned and will give information on how the influx of holidaymakers affects the subsidy scheme. This to enable better control over visitor bus use.
 - DCC will have to bid for allocation from The Local Sustainable Transport Fund. As the region is considered to be relatively 'rich', it will not qualify fro some of the funding available.

Response to the Core Strategy Consultation – John Shave

Consider: Does the consultation contain the right approach?

Infrastructure is a priority. The suggestion was made that there should be no building until infrastructure had been provided for existing residents.

Felt it was correct to concentrate on the urban areas where infrastructure is needed.

There is a need to look at quick wins and solutions- reducing traffic speed would be a good achievement. Could local authorities do this through Localism?

The bus companies find it difficult to keep to times due to delays at junctions. Would a reduction in speed limits help?

It is necessary to ensure that the right infrastructure which is needed for new development is in place and then work on what else is needed.

Consider:- What form should transport improvements take?

The only way forward seems to be public transport but how can improvements be made? KT said the government were now allowing revenue funding which would potentially help.

Need to encourage young people to use buses by reducing fares and more publicity of existing schemes.

Need to examine ways of encouraging bus use which pays.

Encourage cycling by reducing traffic speeds and the provision of paths. Cycle paths should be suitable for use in all weathers and after dark; they need to be surfaced and lit. This makes them suitable for cycling to work and school as well as recreational use.

Cycle links are needed to make links from existing routes to employment areas, schools and shops.

<u>Summary of improvements needed:</u> Speeds limits reduced; Cycleway improvements; Public transport improvements

Members were urged to respond individually & on behalf of the groups they represent.

Health and Community Issues Focus Group 22 November 2010

Facilities - are there gaps in provision, will they be accessible and how else can they be provided?

Does the Core Strategy address these issues?

Buildings / Schools / Co-location

- Do we know how well existing facilities are used? Does the PPG17 survey supply enough detail? Need to know who is using a hall not just where one is located. How much of the community are served by a hall? Is it the same old faces all the time? There is a need to advertise what we already have and do and make better use of the buildings. There is probably a large enough stock of buildings if not a surplus in some places- what does PPG17 say? Should facilities and provision of services be joined up? The running of buildings could be consolidated and pulled into hubs.
- Libraries Kinson not just a library more of a community hub.
 Maybe the Council has to be the lead?
- · Community centres need to be multi-use.
- Schools are developing a community cohesion policy which may help.
- More schools should be used for local facilities and youth facilities should be provided at existing places such as the Tivoli and the Regent Centre.
- Verwood lacks leisure facilities and a swimming pool. Alderholt has a lack of facilities.
- Opportunity accessibility using facilities better, bringing services to people – using The Hub as a focal point.
- Good facilities but not always in the right place.
- Need to co-locate to maximise uses.
- Blandford is the nearest learning centre for expelled children.
- Need porous boundaries work better with Poole and Bournemouth and the health services.
- Like sports park free space for hospital.
- Education issues buildings are under used could compete with other community facilities – when in charge of own budget.

Health

- GP's practices are needed to deal with new residents resulting from development. Can they be developer funded?
- Can we keep people fitter so that less GPs are needed? People are
 frightened about moving around which must be linked to obesity. More
 information is needed on how to look after yourself, perhaps spreading
 the message through networks and building on the work already being
 carried out by POPPS. The project is based on sharing information
 with older people, developing initiatives and using both formal and
 informal channels of information.

- The concern was raised that obesity will be accepted, eg larger seats on public transport etc, how can this be fought against? How can children be educated to allow children to play? How can facilities be provided to get people moving?
- Combine health services.
- PCT will be gone soon. GP's commissioning services.
- Need to identify the demands eg. The Hub; Wimborne Hospital colocating medical facilities.
- Childhood obesity need child stimulation
- Ricketts in children lack of outdoor activity / sunshine.
- Anxiety / depression helped by light exercise.

Transport

- The only good play space/open space in EDDC is Moors Valley. Its location means that many people have to drive there although the ability to cycle from Verwood and potentially Wimborne is noted. Additional cycle routes are needed and more signage.
- Linked cycle paths.
- Our public transport cannot be relied on.

Projects

- Artsreach is a way of reaching older people in rural and suburban areas, taking projects such as this adds to the income of village halls.
- Community events which cut across ages would help and would create more community cohesion. Bridport has a community feel but the Mudeford Street Party is no longer. Wimborne is a very successful community. There is a need to bring diverse communities together, perhaps events based. Community garden competitions can bring communities together. The garden idea links to health issues.
- Community allotments could be provided through development.

Young People

- Young people need a sexual health clinic in Wimborne; youth facilities are generally needed in East Dorset. There are fundraising issues about the Reef, Corfe Mullen YC is still good but Heatherlands has closed. There is a lack of provision for young people in Alderholt.
- There is a need to involve other bodies to form a hub for young people and activities need to be provided for older teenagers.
- The Core Strategy needs to help with the issue of children's play, there
 is a fear of letting children go out to play. Spaces are needed for
 children, not just playgrounds. Shared places are also needed,
 perhaps open air gyms, outdoor table tennis tables.

Rural Areas

 More of a problem for the rural areas where populations are not big enough – no bus services – rural isolation.

Other comments

- Reaching the working population is difficult.
- Communities are no longer local due to the internet and families living all over the country.
- Members of the Asian community in Leicester are moving south in retirement, this could cause problems as this are has less support than in Leicester, issues over language translation and isolation.
- Developer contributions are needed to provide facilities.
- People would like police houses.
- Need to manage expectations.
- Understand the demands of change.

Healthy Lifestyles and Community Safety Does the Core Strategy address these subjects?

Family based activities are needed; walking, safe cycling to school and leisure centre. People travel to the countryside by car to walk the dog.

It is difficult to get between settlements by walking or cycling and this includes settlements across the border with Hampshire. There are few identified paths or those that there are do not go far enough, eg there are no public paths near Furzehill. Maintenance issue too. Need to create places which are safe to walk and cycle.

Transport Issues-Lower speed limits are needed on rural roads.

Walford Mill is cut off by traffic.

Need pedestrian priority areas, 20mph in towns, accessibility for the disabled.

Good park space is required in new housing options for children.

Leigh Park needs community based play facilities.

One example was given of a GP practice which has been put into a park and it has used the park to expand its facilities and services. It is now a health education provider; it runs the park and a café, promotes well being and is virtually self financing.

There is a need for arts on prescription for the unemployed, those with depression or special needs.

Regular sports course are needed such as those at Heatherlands.

Community safety- where it is known there are paedophiles living in the area, parents are reluctant to let children out to play.

Access to allotments should be included for affordable housing, this would improve community cohesion and would help with new neighbourhoods. This has been done in German and Dutch towns. Communal gardens need to be designed to get people to use them and to allow access for exercise.

There is a gap in youth provision, need to find out what youngsters want and therefore what to provide. This links with issues over accessibility and the cost of transport.

More people are less active in Christchurch, when age is taken into account. How can people be persuaded to change their minds about activity?

Need to provide places which all age groups can use.

Choice of leisure facilities is needed even in small settlements. There is a need to build activity levels into lifestyles and needs to be at the door rather than a half hour drive away.

There is a need to provide for some ethnic groups and women only-issues around body image. Hiring facilities for the group can be expensive and therefore those groups miss out.

Need to link weight groups with exercise facilities. Improvements now lead to lower costs to the NHS later.

Mental well being is also important. Access to groups and activities such as bridge is helpful.

How do older people keep in touch with others? How do you get isolated people together? Use day care facilities?

Twin private and state schools locally.

Living Space Standards are important to the quality of life. More space leads to better community relations and less noise issues as well as to better mental health. Space in houses affects people's lifestyles and overcrowding can lead to mental health issues.

Community Safety Issues-Fear of crime by people least likely to be a victim Expectations of the area to be perfect People living alone Living in blocks of flats can cause problems Community is very important

The way housing is designed is very important to help combat social problems Very important to have living rooms that cannot be converted to bedrooms There are environmental triggers to social problems

Planning can only do so much, the Core Strategy cannot do it all.

Need to retain younger people.

High need for affordable housing

Poor housing design results in ghettos

rely on the Heathland IPF – keep it separate from the heathland pot – lots of people would like to see it retained as a separate fund. Heathland scoring system is mitigation based, whereas GI doesn't always mitigate impacts on heathlands – just provides open space. Retain Heathland contributions in-house as we know what we are dealing with. On the other hand it was pointed out that you can't separate all the different elements of GI – you need to treat it as one vast green network, all quite fragmented at the moment.

It was pointed out that providing green spaces and ecosystems would create very attractive living environments, and this will make the housing more desirable.

Need to consider how the money would be spent – collect locally and spend locally in the individual LNA's.

SANGS and open space would be provided in conjunction with new housing development – locally based. Size of SANGS required – need guidance from CABE or Natural England on this.

Health aspects discussed and importance noted – Moors Valley given as an example; GP referral, buggy walks.

Allotments – Core Strategy proposes new sites for allotments – where there are proposals for development – improvements to existing provision.

SSSI's – need to look at access patterns and establish educational facilities on site.

Council Chamber Group Responses for 1, 2, 3 (JS)

Land ownership will always be an issue in the delivery of new sites

Need to look equally at access to nature, not just the provision of new open space.

Proposals for habitat re-creation should be shown on proposals maps or key diagram

The question arose of whether sites would be statutory or non-statutory

Targets for re-creation should be aspirational.

Either proposed new SANGs or areas of search for future SANGs should be shown on CBC/EDDC key diagrams or proposal maps – not just the Joint Heathland DPD.

Council Chamber Group Responses for 4, 5 (SK, KE)

GI – relies on CIL – Core Strategy has lots of Options – unless CIL is delivered in large amounts – how will it deliver large amounts of GI? Will CIL pot be large enough to deliver all development requirements (transport / affordable housing etc)? – must be provided at the beginning of the development.

SANGS – importance recognised - eg. Roeshot Hill SANG – to mitigate development.

Tariffs - ref to Milton Keynes tariff; WDDC planning tariff – recognised that major infrastructure can't be provided on a tariff basis – will have to be part of the development. Mention made of using other funding streams.

Need to incorporate Heathland contributions into CIL schedule The mechanism for each authority to adopt CIL is very complicated and would need to be updated each year in a business plan.

Heathlands DPD – key in terms of people's health, mental health and well being / sports centres / swimming pools etc. Moors Valley given as an excellent example.

DWT prefer the Non-preferred option.
