The consultation statement fails to refer to significant meetings undertaken with Senior Representatives of the LPA in 2012 which assessed 14 possible sites for a new Village Hall. Of crucial significance is that this process identified the Chaffey Moor Farm site as being unacceptable. The same process recognised the land adjoining Sandways Farm to be the most suitable location of all options for a new hall.

The consultation summary has failed to properly detail the objection made to the pre-submission plan on behalf of the owners of the land adjoining Sandways Farm. Not only did this identify that the assessment process was flawed it also pointed out significant inconsistencies between the findings of earlier supporting documentation (e.g. the Village Design Statement) and the subsequent proposed allocation of the Chaffey Moor Farm (Jubilee Field) site. No reference is made to observations about potential impact on heritage assets of developing the Jubilee Field site.
