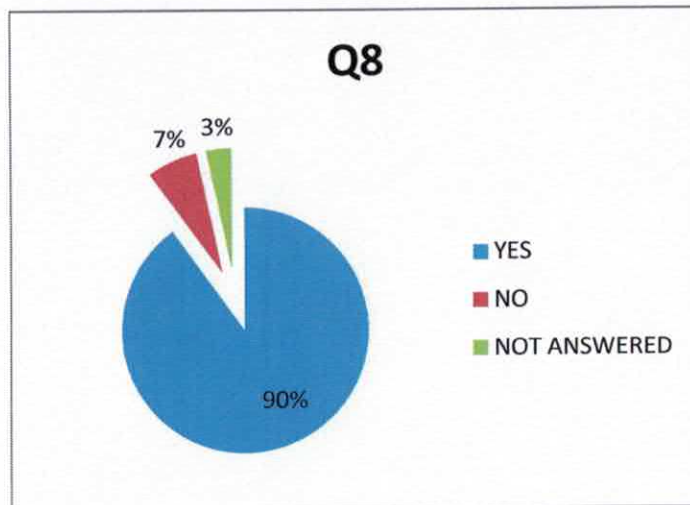


**Q8. Do you support the continued request for the Health Centre?**

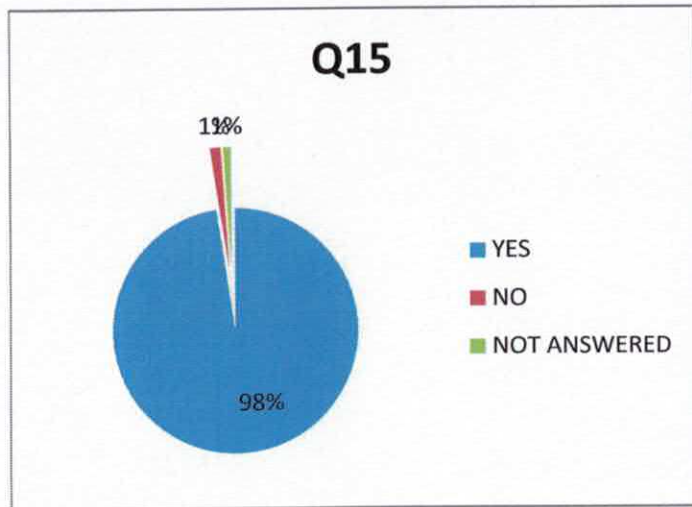
