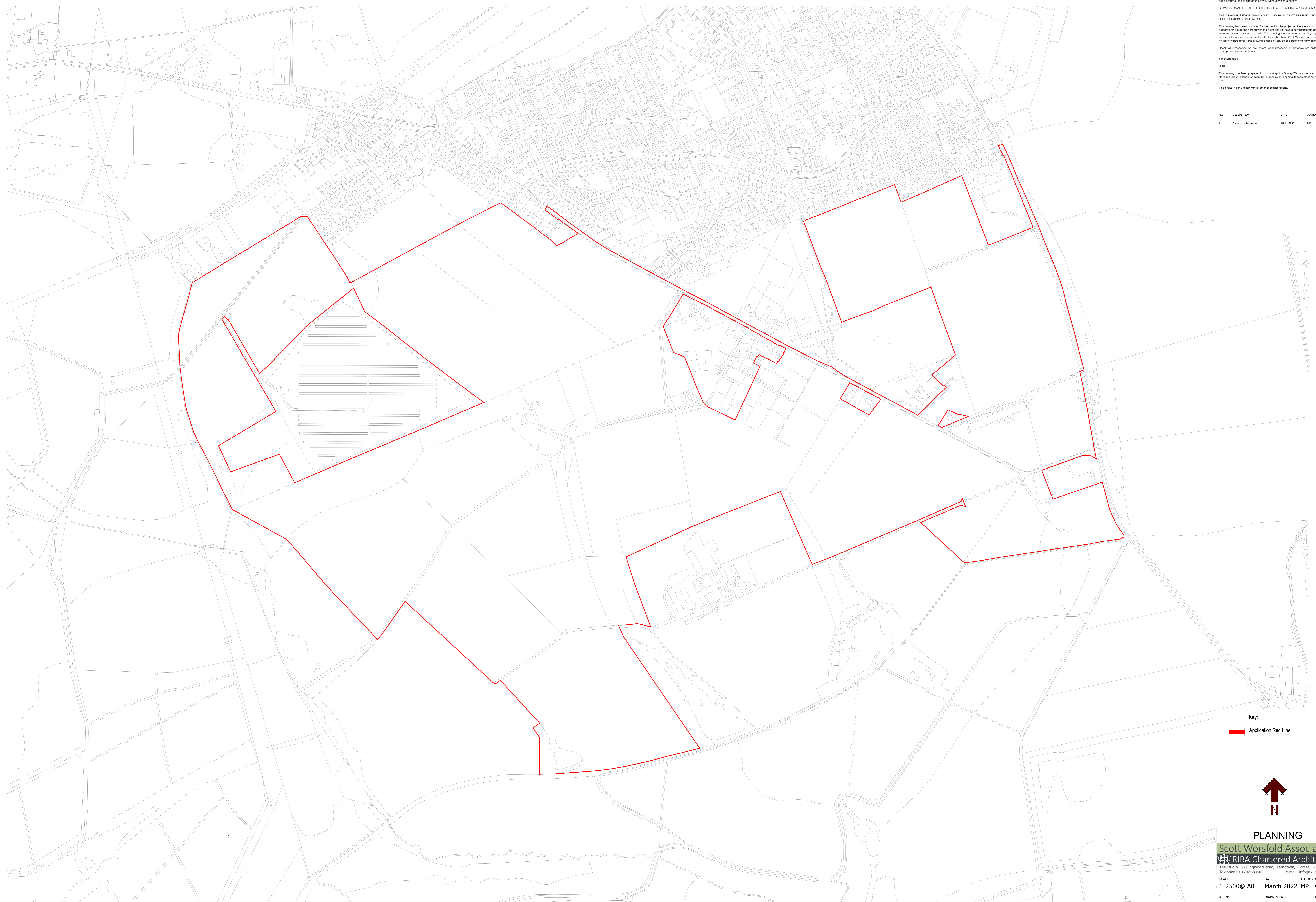

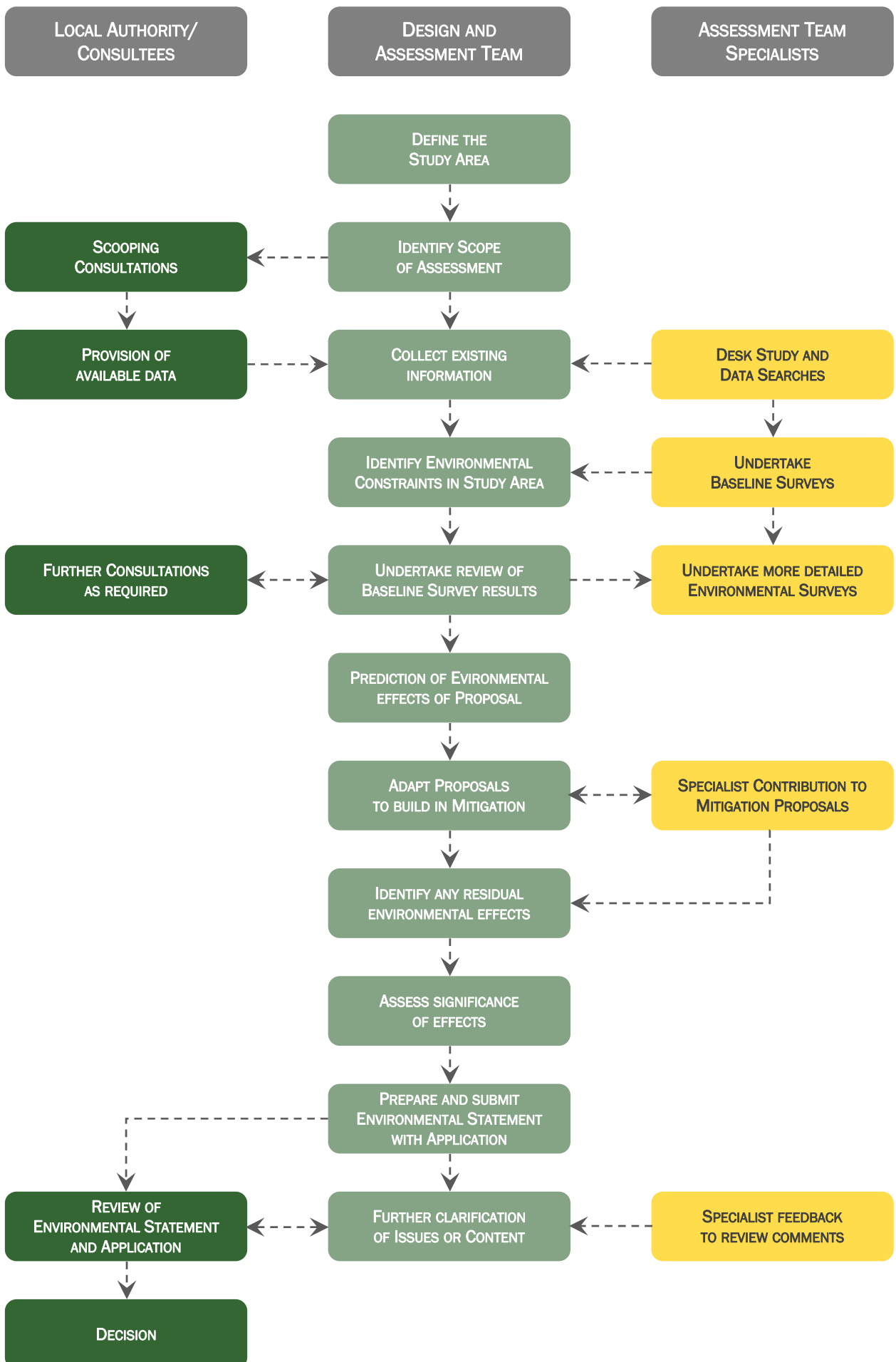

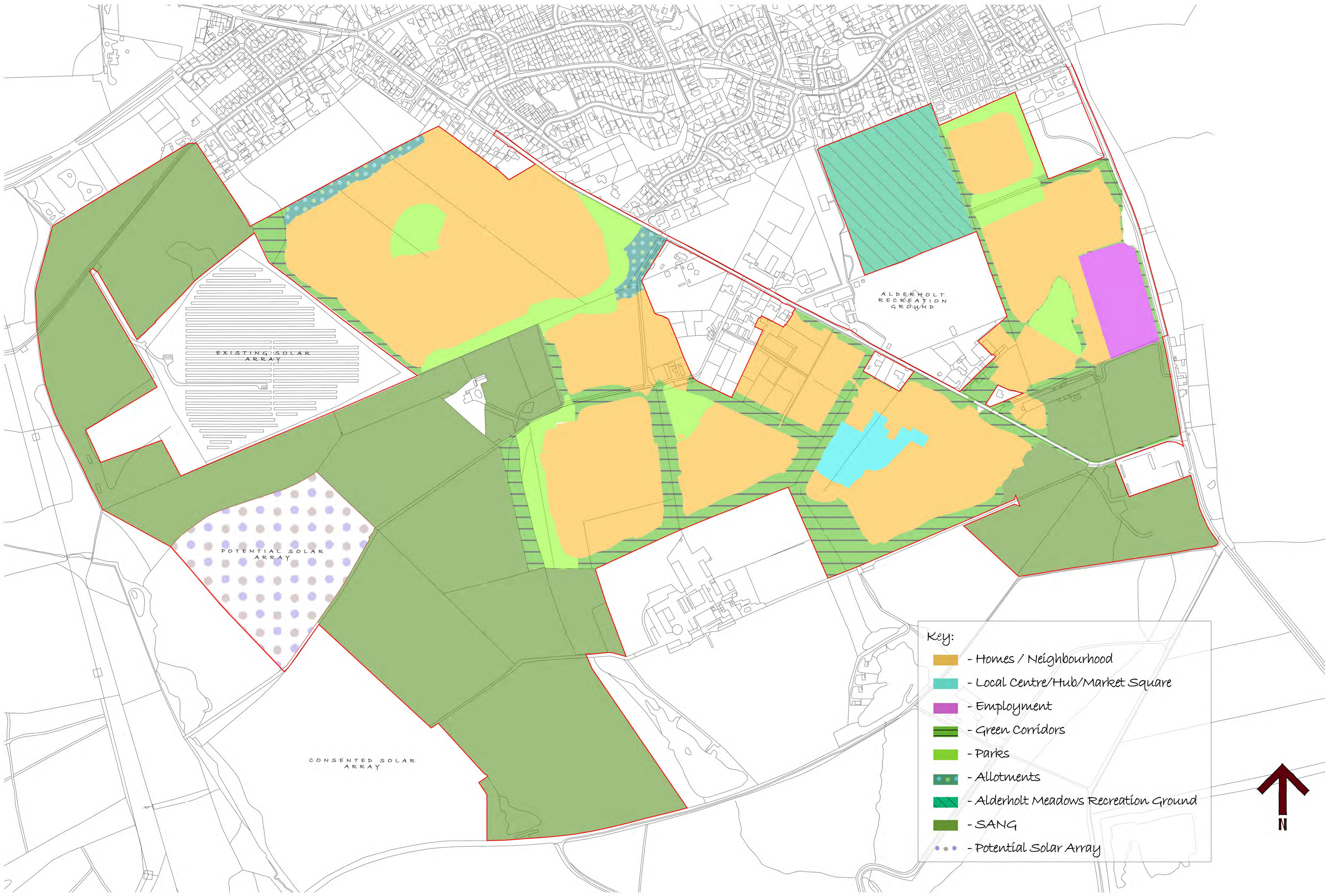


Figure 5.1 - Land Use Parameter Plan

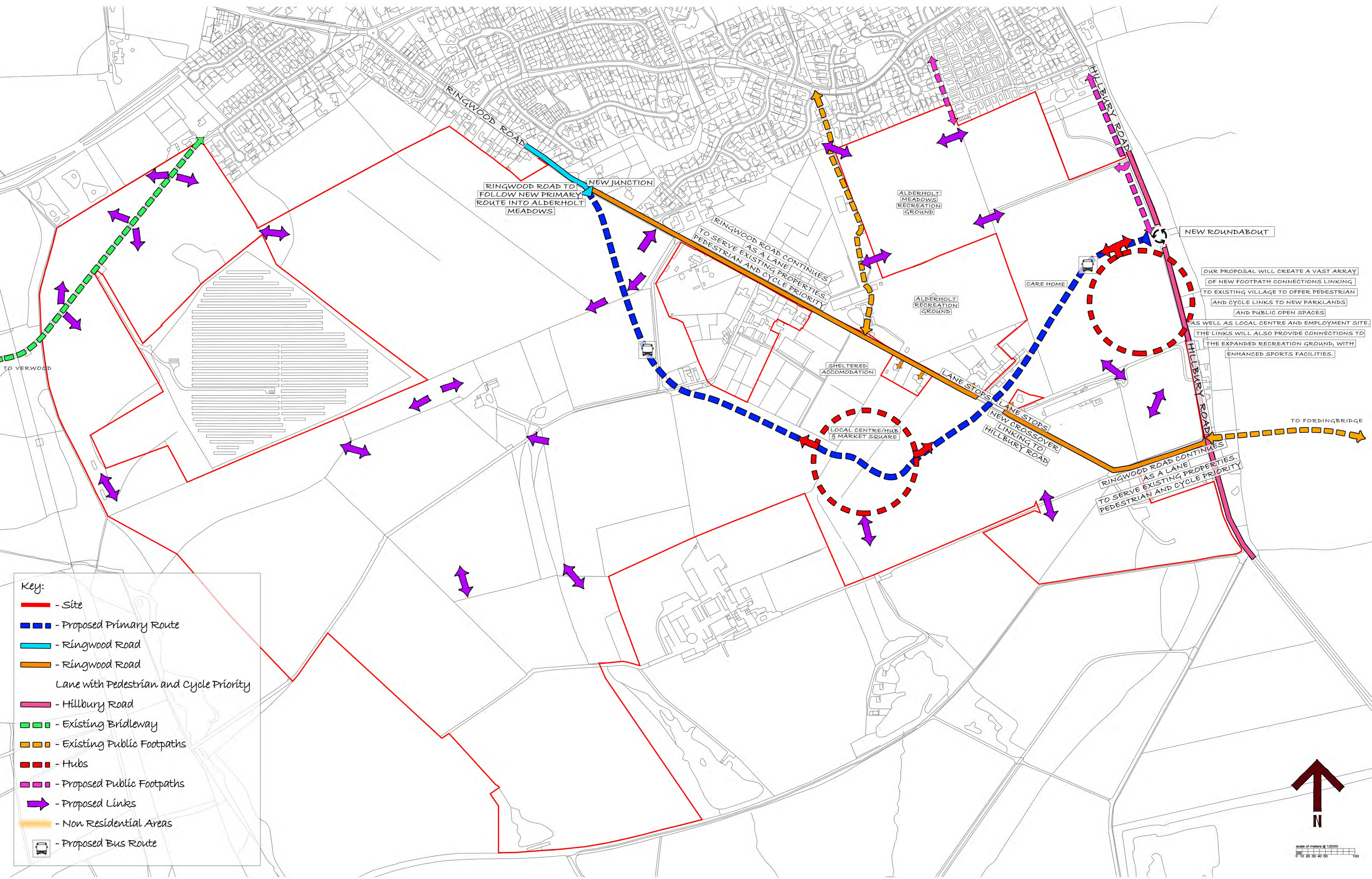


Figure 5.2 - Access and Movement Parameter Plan

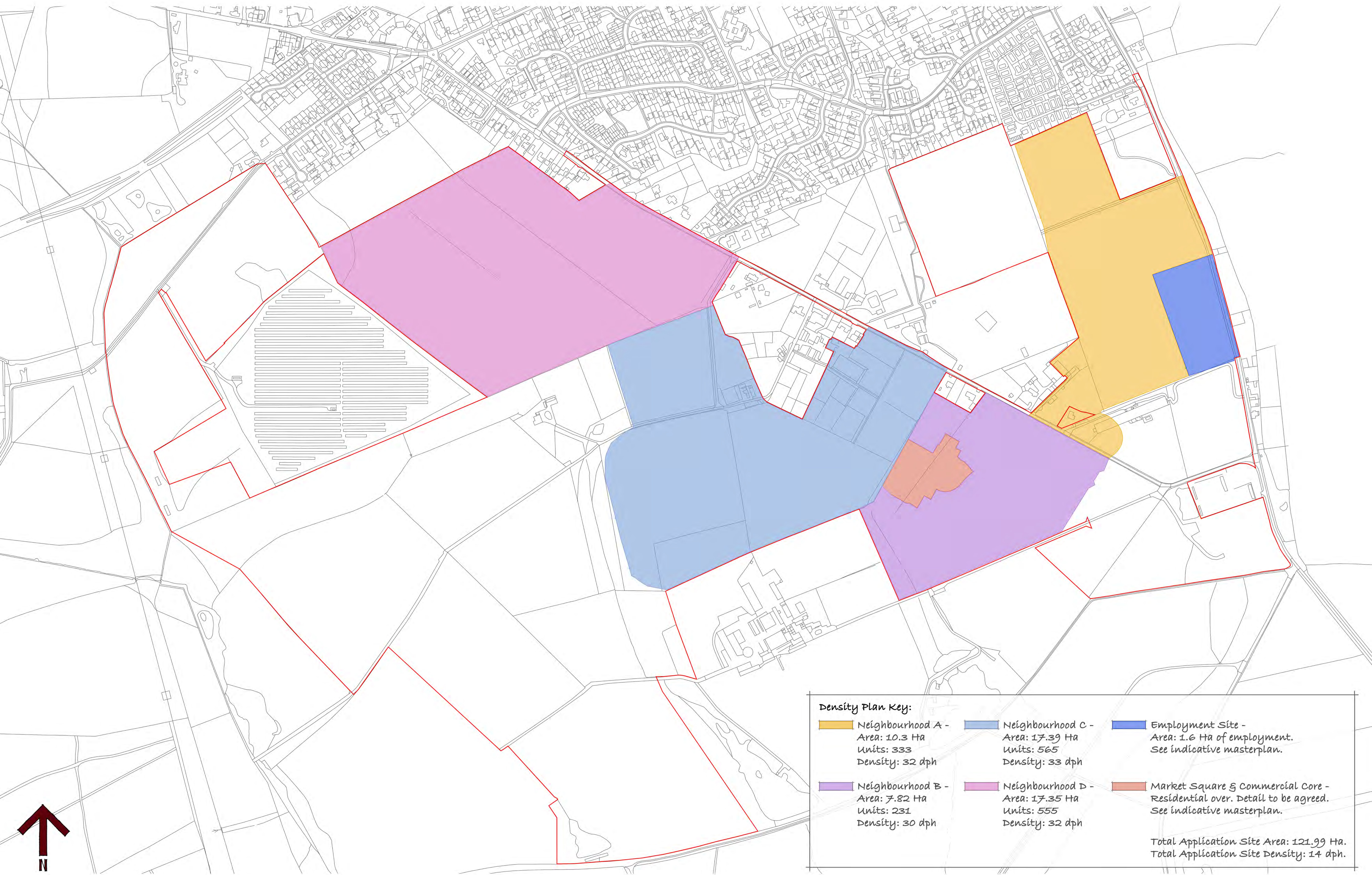
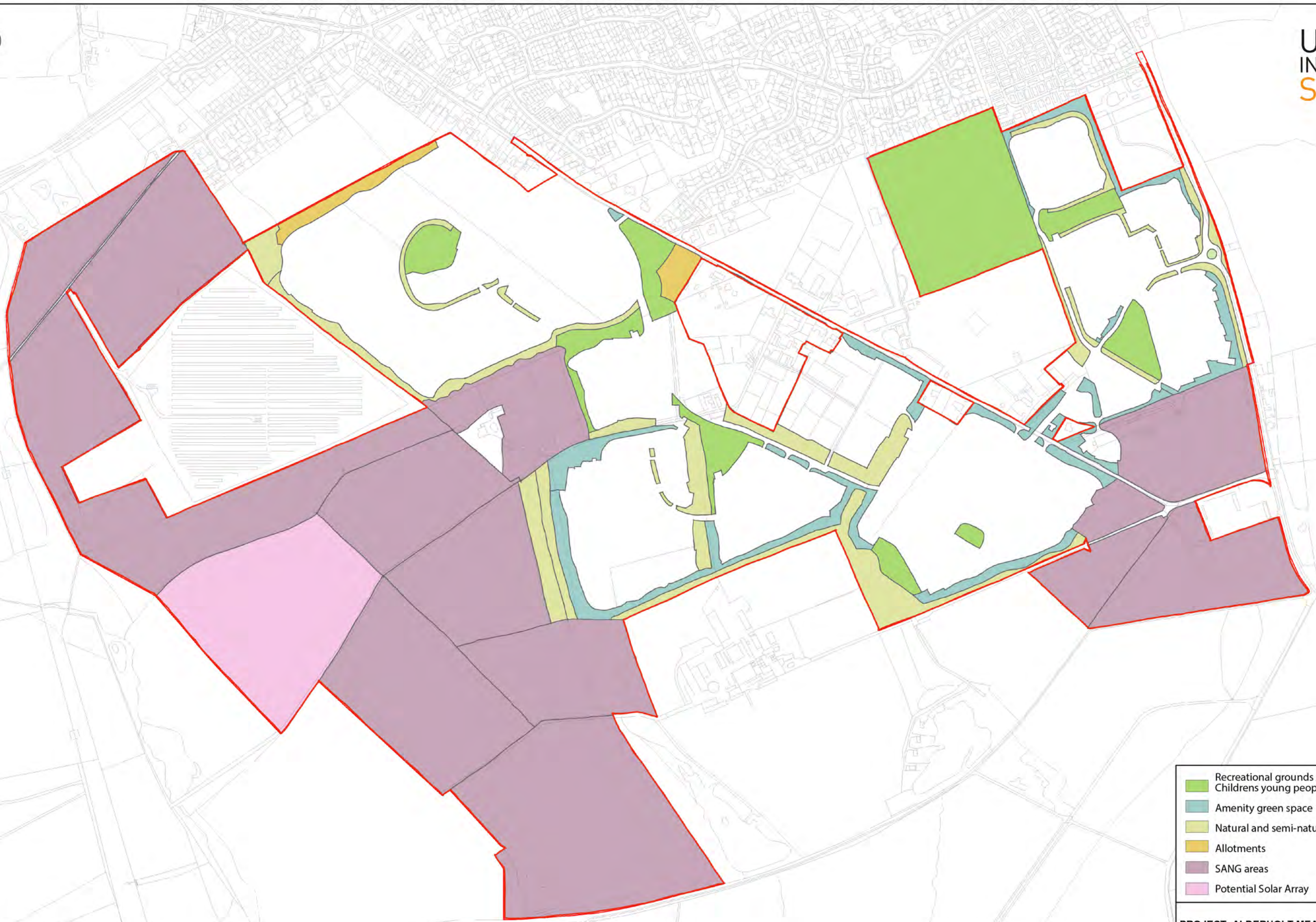
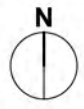


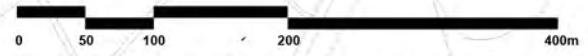
Figure 5.3 - Density Parameter Plan

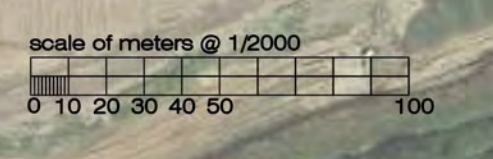

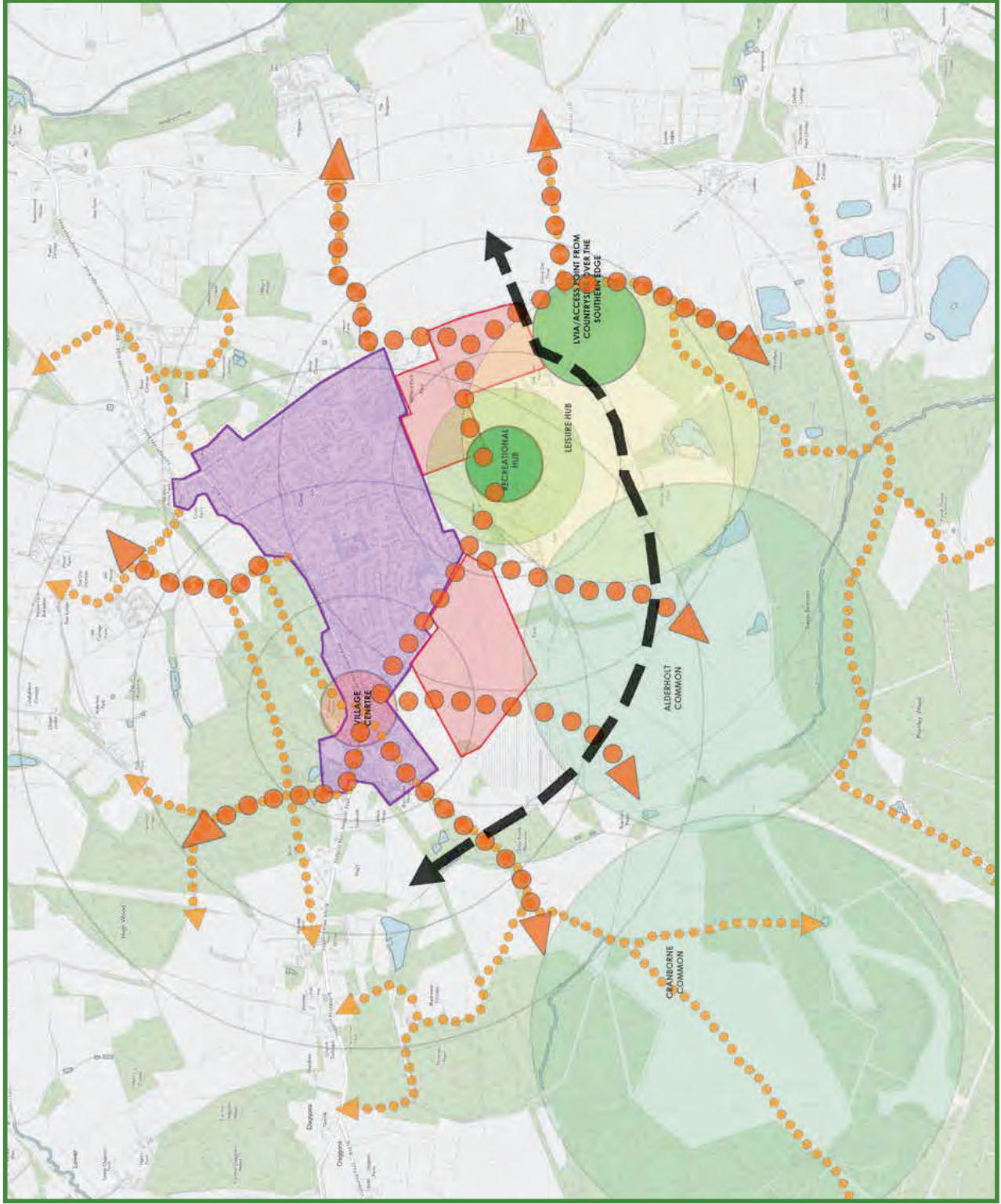
