**Public Path Diversion
and
Definitive Map and Statement Modification Order**

**Highways Act 1980
Wildlife and Countryside Act 1981**

**Dorset Council (Part of Footpath 14, Lydlinch)
Public Path Diversion Order 2024**

This Order is made by Dorset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Dorset definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Mrs M Woodford has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Lydlinch Parish Council has been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at Lydlinch and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation of this Order or on the date which Dorset Council certify that work has been carried out to bring the site of the new highway mentioned in Part 2 of the Schedule to this Order into a fit condition for use by the public, whichever is the later and thereupon the County of Dorset definitive map shall be modified by deleting from it that public right of way.
2. Notwithstanding this Order, where immediately before the date on which the path is diverted in pursuance of this Order, there is apparatus under, in, on, over, along or across the path belonging to the statutory undertakers for the purpose of carrying out their undertaking then such undertakers shall continue to have the same rights in respect of their apparatus as they would have had if this Order had never been made.
3. There shall at the end of 7 days from the date of confirmation of this Order be a public footpath over the land situate at Lydlinch described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained

in this Order and thereupon the County of Dorset definitive map shall be modified by adding that path to it.

4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule to this Order
5. The County of Dorset definitive statement shall be modified as described in Part 4 of the Schedule to this Order.

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Part 1

Description of site of existing path

Part of Footpath 14, Lydlinch:

- A-B-C The whole width of the footpath from point A (ST 75686 12005) generally north to point B (ST 75690 12072) and then generally north east across a paddock to its junction with Footpath 55, Sturminster Newton at the parish boundary at point C (ST 75841 12127)
(No recorded width)

Part 2

Description of site of new path

Part of Footpath 14, Lydlinch:

- A-D-E-F- From point A (ST 75686 12005) east south east across a grass field to point
C D (ST 75708 12006) then north into a second field and east to point E (ST 75734 12007) generally north and north north east to point F (ST 75740 12030) and following the boundary of a wooded area generally north east then north, north west and north to point C (ST 75851 12127). Width, 2.0 metres between A (ST 75686 12005) and D (ST 75708 12006) and 2.5 metres between points D (ST 75708 12006) and its junction with Footpath 55, Sturminster Newton at the parish boundary at point C (ST 75851 12127) except at point D – pedestrian gate to BS5709:2018

Variation of particulars of path

Footpath 14, Lydlinch:

Delete:

From: ST 75695 11833 To: ST 758121

From its junction with Bridleway 5 on Haydon Lane, in a north-westerly direction along a grass/compacted stone surface for 15 metres to ST 75688 11846 and continuing in a northerly direction for 161 metres to a gap at ST 75686 12007 and in a northerly direction for 64 metres to ST 75690 12072, then continuing on a grass/natural surface in an east north-easterly direction for 162 metres to ST 75843 12121 and continuing north east to its junction with Footpath 55 at the Sturminster Newton parish boundary (thence to Puxey Lane).

Add:

From: ST 75695 11833 To: ST 75851 12127

From its junction with Bridleway 5 on Haydon Lane, in a north-westerly direction along a grass/compacted stone surface for 15 metres to ST 75688 11846 and continuing in a northerly direction for 160 metres to ST 75686 12005 and then in an easterly direction to a pedestrian gate at ST75708 12006, then east to ST 75734 12007, north to ST75740 12030 and then north, north easterly to ST 75851 12127 to the junction with Footpath 55 at the Sturminster Newton parish boundary (thence to Puxey Lane).

Width 2.0 metres from ST 75686 12005 to ST 75708 12006, 2.5 metres from ST 75708 12006 to ST 75851 12127. Limitation: Pedestrian gate to BS5709:2018 at ST 75708 12006.

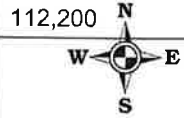
