

The County of Dorset (Various Roads, Sherborne) (30mph, 40mph and 60 mph Speed Limits) Consolidation Order 2024

Dorset Council in exercise of powers under the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with paragraph 20 of the Schedule 9 of the Act 1984, hereby make the following Order:-

1. No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour in the lengths of roads specified in Schedule 1 of this Order.
2. No Person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour in the length of roads specified in Schedule 2 of this Order.
3. No person shall cause or permit any vehicle to be driven at a speed exceeding 60 miles per hour in the length of roads specified in Schedule 3 of this Order.
4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
5. The following Orders will become revoked on the date of commencement of this Order as follows:-

 "The County of Dorset (Various Roads, Sherborne) (30mph and 40mph, Speed Limits) (No.5) Order 2024"

 "The County of Dorset (A30 Yeovil to Shaftesbury Road) (60mph Speed Limit) (No.14) Order 2024"

 "The County of Dorset (B3148, Marston Road, Sherborne) (30mph Speed Limit) 2002" and its Variation Order "The County of Dorset (B3148, Marston Road, Sherborne) (30mph Speed Limit) (No.3) Variation Order 2023"
6. This Order may be cited as "The County of Dorset (Various Roads, Sherborne) (30mph, 40mph and 60 mph Speed Limits) Consolidation Order 2024" and shall come into operation on the 13th day of December 2024.
7. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.

Schedule 1

30 mph Speed limit

| Road | Description |
|---|--|
| A352 (Horsecastles Lane and Ottery Lane), Sherborne | From its junction with the A30 in a southerly direction for a distance of approximately 1.10km. |
| A352, Westbury, Sherborne | From its junction with the A352 (Ottery Lane) in a southerly direction for a distance of approximately 546 metres. |
| New Road, Sherborne | From its junction with the A352 (Westbury) in a Northernly direction for a distance of approximately 140 metres. |
| B3148 Marston Road, Sherborne | From a point 33 metres north west of its junction with the north western side of Highmore Road for a distance of approximately 8 metres in a north westerly direction. |

Schedule 2

40 mph Speed Limit

| Road | Description |
|--------------------------------------|--|
| New Road, Sherborne (B3145 and C160) | From a point approximately 41 metres southeast of its junction with Long Street/ Osborne Road (the terminal point of the existing 30mph speed limit) in a southerly direction for a distance of approximately 1.4km. |
| B3145 (Gas House Hill) | From its junction with New Road in north westerly direction for a distance of approximately 60 metres (the terminal point of the existing 30mph speed limit). |
| A352, Sherborne | From a point approximately 120 metres west of its junction with Hardings Lane in an Easterly direction for a distance of approximately 427 metres. |

Schedule 3

60 mph Speed Limit

| Road | Description |
|--------------------------------|--|
| A30 Yeovil to Shaftesbury Road | From a point approximately 335 metres west of its junction with the A352 in a south westerly direction for a distance of approximately 5.1 km. |
